

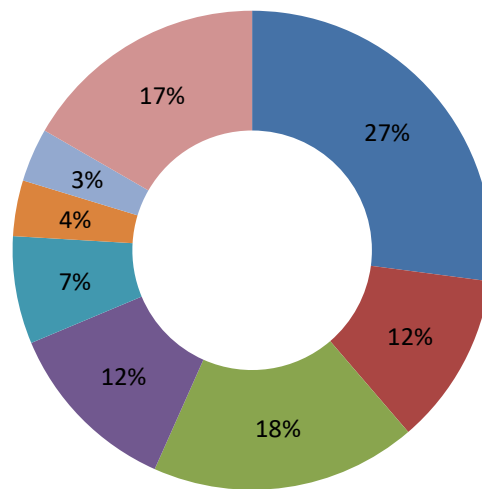
## 2017 Annual Report

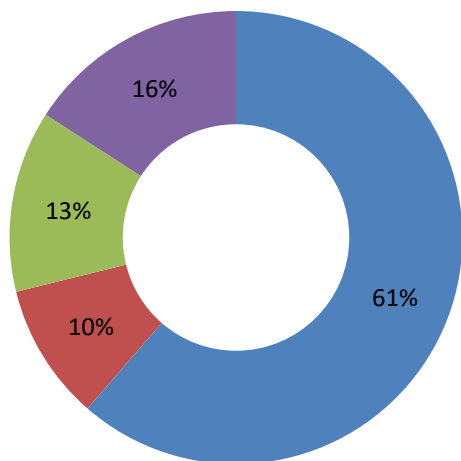

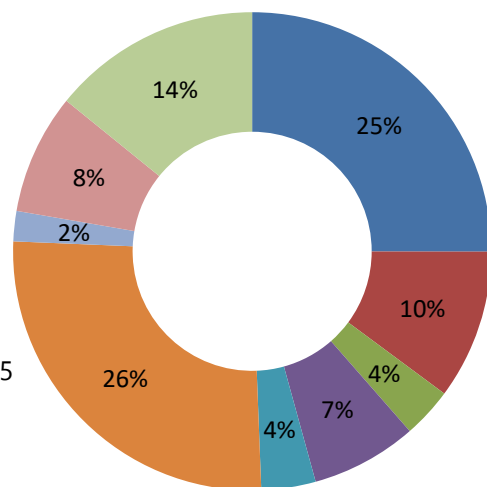
